 - Within one year, you provide a written report or oral presentation to the Peninsula Rotary Club, describing conclusions, progress, and status of objectives including how funds were expended.
 - You furnish, to your Rotary contact, any information concerning a change in the proposal or a change in grantee's tax exempt status.
 - If grantee's exempt status changes or if funds are not used for the purposes described in your proposal the Foundation reserves the right to have all remaining grant funds immediately returned.
 - Grantee warrants that funds will only be used for the purposes allowed by the IRS and other government agencies relating to grants from private foundations. In particular, no funds will be used for lobbying purposes or to aid in the election of a public official.
